Services Director*

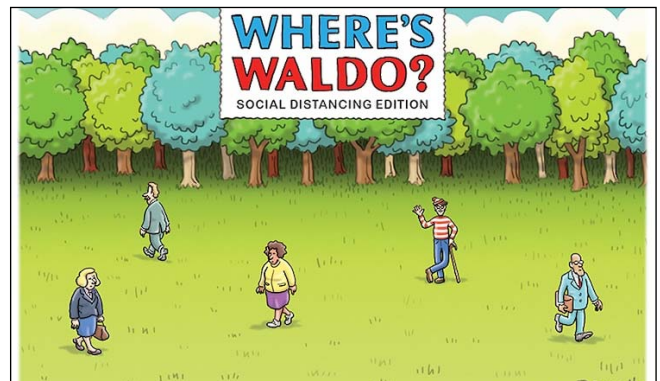
